Enhancing Critical Care at Sturgeon Community Hospital (Intensive and Cardiac Care Units).

The Sturgeon Community Hospital Foundation has committed to raising funds for crucial equipment enhancements in our Critical Care Unit. These upgrades are essential to improving our ability to provide advanced care to seriously ill patients within our community, ultimately saving lives.

#### **PROJECT NEED**

The Critical Care Unit cares for the sickest of the sick. Access to specialized medical equipment is vital for the effective treatment of critically ill patients. By upgrading our equipment and expanding specialized treatments, we can provide comprehensive, high-quality care locally, reducing the need for patient transfers and improving overall patient outcomes.

The project involves upgrading our Critical Care Unit with advanced medical technology, including:

- Advanced Ultrasound technology for precise diagnosis and treatment.
- Intermittent Hemodialysis (IHD) Program to expand dialysis treatments.
- Therapeutic Bronchoscope, vital for respiratory care and reducing the need for invasive interventions.

#### EDUCATION & INNOVATION - CLINICAL SIMULATION CENTRE

The Sturgeon Hospital is a CENTRE FOR TEACHING EXCELLENCE!

The Sturgeon Hospital Foundation successfully raised \$1 million to support the creation of a state-of-the-art Clinical Simulation Centre at the Sturgeon Hospital. The SIM Centre, which will be fully operational in February 2025, will provide physicians, nurses, respiratory therapists and all other healthcare professionals with the ability to interact with computerized medical manikins, anatomical models and digital learning platforms.

Then SIM centre will improve patient outcomes and safety through hands-on learning with life-like simulation technology. With a long history in sectors like aviation, sports and military, simulation learning can be customized to ensure realistic environments that support the training of the newest members of a profession or challenging the most senior practitioner.

This advancement has moved the status of the Sturgeon Hospital to a teaching hospital, which will help retain and attract highly skilled physicians and frontline workers in and to our community.



#### ADVANCED MEDICAL EQUIPMENT - EMERGENCY DEPARTMENT CARDIAC MONITORS

The Sturgeon Hospital Foundation successfully supported the initiative to have cardiac monitors for every bed, linked to a central observation station, ensuring that patients receive the care they need, when they need it. This technology, which will be fully in place in 2025, will enhance patient outcomes through improving the efficiency of our Emergency Department - ensuring we see more patients each day with the least amount of intra-hospital patient moves.
